

## ELIGIBILITY:


- Compulsory for all the BALLB V YEAR AND LLB III YEAR students
- Open to all students enrolled in BALLB AND LLB course
- Students may participate in teams of two or three.

## FORMAT OF THE COMPETITION:

- The competition will follow a knockout/round-robin format.
- Each team will present oral arguments as both petitioner and respondent in preliminary rounds.
- Top teams will qualify for the final rounds, judged by experienced faculty, advocates, or judges.
- Memorial Submission is mandatory for each team.



## TEAM COMPOSITION

- Each team shall consist of a minimum of two members and maximum of three members. This team composition cannot be altered under any circumstances.
- Every team shall consist of two speakers. Teams may have only one researcher.
- Upon completion of registration, team code will be allotted to each team. Thereafter all correspondence shall be in reference to that team code.
- The same team code must be used by the teams during submission of memorials and oral rounds. Teams must not disclose the identity of their College/University anywhere in the Memorial. Violation of this Rule shall attract severe penalty at the sole discretion of the organisers.



# THE MEMORIALS


## Contents of the Memorial

**The Memorial shall comprise of the following parts:**

1. Cover Page (Blue Cover – Claimant/ Red Cover –Respondent)
2. Table of Contents
3. List of Abbreviations
4. List of References and Cases
5. Statement of Jurisdiction
6. Statement of Facts
7. Statement of Issues
8. Summary of Pleadings
9. Detailed Pleadings
10. Prayer

Each team must submit the 2 copies of memorial from each side, i.e 2 from plaintiff and 2 from defendant.

Each memorandum shall have the following and only the following on its




## **COVER PAGE:**

- a) The team code on the top right-hand corner of the Cover Page.
- b) The name and place of the forum.
- c) The relevant legal provision under which filed.
- d) Name of parties and their status.
- e) Memorandum Filed on Behalf of.

## **FORMATTING**

**All memorials submitted must conform to the following general requirements:-**

- Memorial must be typed in MS Word with black font on A4 page size.
- The body of the memorial must be in font Times New Roman, Size 12; 1.5 line spacing.
- Footnote must be Times New Roman Font, Size 10; 1.0 line spacing.
- Teams should use the Bluebook method of citation for footnoting.
- Footnoting style must be consistent throughout the memorial.



- Each page must have a margin of at least one inch on all sides.
- There should not be any borders on the pages.
- The Memorial should not exceed 25 typed pages, of which the
- arguments advanced should not exceed 15 pages.

## PLAGIARISM

Participants must refrain from using same language or copying from other's memorials and other sources. Even use of publicly available information must be accompanied by proper citations.

These rules shall apply to all parts of the memorial


and not just the Pleadings and Prayer. Failure to comply with this rule may result in the guilty participants being debarred from mooting

in FIMT School of law. The Organizing

Committee in consultation with the


memorial judges will take a final decision regarding determination


Winners may also get the chance to represent the institution in external moot court competitions.


